An approved QSP Assessor will be designated to you following the registration process who will offer all the support and guidance to assess you through the qualification. The qualifications are assessed 'on-the-job'.

Individuals will be required to build a portfolio of evidence which will be assessed against the set WAMITAB standard; the evidence will be collected by carrying out normal day to day duties.

On successful completion of these qualifications candidates receive a QCF Certificate of Achievement along with their portfolio which has recorded their achievement to keep as reference.
